We refer to Regulation 15 (2) of Chapter IV of SEBI [Listing Obligations and Disclosure Requirements] Regulations, 2015 notified on 2nd September 2015 and latest amended on 5th December 2022.

Under the said Regulations, compliance with the Corporate Governance provisions as specified in Regulations 17, 17A, 18, 19, 20,21, 22,23,24,24A, 25,26,27 and clauses (b) to (i) and (t) of regulation 46(2) and para C, D & E of Schedule V shall not apply to the listed entities having paid up Equity Share Capital not exceeding Rs. 10/-Crores <u>and</u> Net Worth not exceeding Rs. 25/- Crores as on the last day of the previous Financial Year.

As per the latest Audited Balance sheet as on 31st March 2023, the Net Worth of the Company is Rs. 16.24 Crores i.e less than Rs. 25/- Crores and the Equity Share Capital is only Rs. 4.02 Crores i.e. less than Rs. 10/- Crores, as stipulated.
