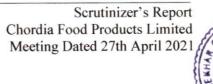

- 1) Combined Scrutinizer's Report on Remote E-Voting and E-Voting at NCLT Convened Meeting of Members of the Company held on Tuesday, 27th April, 2021 through Video Conferencing(VC)/ Other Audio Visual Means(OAVM)
- Combined Voting Results, pursuant to Securities Exchange Board of India SEBI Circular No. CFD/DIL3/CIR/2017/21 dated 10th March, 2017 (SEBI Circular).

Ref:- Regulation 44(3) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

I, Shekhar Ghatpande Company Secretary in practice, having Membership No FCS:1659 and CP: 782 and having my office at 13, 'Saraswati' 3rd Floor Rambaug Colony, Paud Road, Kothrud, Pune - 411 038 have been appointed as a Scrutinizer by the Hon'ble National Company Law Tribunal, Mumbai Bench [NCLT] for the purpose of scrutinizing the Remote E- Voting and E-Voting conducted at the Meeting of Members of the Company convened by NCLT, held on Tuesday, 27th April 2021 at 11.30 A.M. through Video Conferencing(VC) / Other Audio Visual Means (OAVM) as per the directions of the Hon'ble National Company Law Tribunal, Mumbai Bench and pursuant to the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and in



accordance with Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulation 2015 as amended read with General Circular No. 14/2020 dated 8th April, 2020, General Circular No. 17/2020 dated 13th April 2020 and General Circular No. 20/2020 dated 5th May, 2020 issued by Ministry of Corporate Affairs and circular dated 12th May 2020 issued by the Securities and Exchange Board of India (SEBI) (hereinafter referred to as the "Circulars") that provide relaxation for the manner in which the NCLT convened Meeting shall be held and conducted.

The NCLT Order dated Monday, 15th March 2021 interalia provide for relaxation in the manner in which the NCLT convened Meeting will be held including the manner of sending the Notices to the shareholders and the manner of voting at the meeting, which was necessitated on account of the outbreak of COVID -19 pandemic. Further pursuant to NCLT Order dated Monday, 15th March 2021 and the Circulars, physical attendance of the Members had been dispensed with and accordingly the facility for appointment of proxies by the Members was also dispensed with.

Accordingly I as the Scrutinizer, also attended the Meeting though Video Conferencing (VC).

Members who attended the meeting through VC or OAVM were counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013. The attendance of the Shareholders who attended the Meeting was downloaded from CDSL Portal. The adequate Quorum was present throughout the Meeting.

I submit herewith my Report as under:-

1) Responsibility and E-voting Agency:

The compliance with the provisions of Companies Act, 2013 and Rules made there under read along with NCLT Order dated Monday, 15th March 2021 mentioned above and SEBI Regulations, 2015 relating to remote E-Voting and E-Voting during the NCLT convened Meeting, by the Shareholders on the Resolution proposed in the Notice dated Friday, 26th March, 2021 (Notice) of the Members of Chordia Food Products Limited (the Company), convened as per the directions of the Hon'ble National Company Law Tribunal, Mumbai Bench [NCLT] is the responsibility of the management. As a Scrutinizer my responsibility was to ensure that the process of remote E-Voting and voting electronically at the NCLT convened Meeting is conducted in a fair and transparent manner and render a consolidated Report to the Chairman on the Resolution proposed at the NCLT convened Meeting, based on the Reports generated by E-Voting Platform - Central Depository Services (India) Limited (CDSL).

The NCLT convened Meeting was conducted by Satellite Corporate Services Private Limited, the Registrar and Transfer Agents of the Company as the Host of the Meeting through 'Cisco Webex Meeting' application on the platform of CDSL.

2) Notice of the Meeting and Advertisement:

In accordance with the Notice of the NCLT convened Meeting sent to the Shareholders by way of Email dated 27th March, 2021 and the Newspaper 'Advertisement' published on 27th March, 2021 in Times of India Kolhapur Edition in English Language and on 30th March, 2021 in Daily Eaikya Satara Edition in Local (Marathi) Language pursuant to Rule 20(4)(v) of the Companies (Management and Administration) Rules, 2014 (Amendment Rules 2015) and the Circulars mentioned above, the remote E-voting period remained open from Saturday, 24th April, 2021 (9.00 A.M.) to Monday, 26th April, 2021 (5.00 P.M.).

3) Cutoff Date:

The Shareholders holding Equity Shares as on the "Cut Off' date i.e. Tuesday 20^{th} April, 2021 were entitled to vote on the proposed Resolution mentioned at Item No. 1 as set out in the Notice dated 26^{th} March, 2021 convening the NCLT convened Meeting of Members of the Company.

4) EVSN and Remote E-Voting Process:

The EVSN allotted by CDSL for Electronic Voting was 210326001.

The remote E-voting system was blocked forthwith at the end of the remote E-voting period. The votes cast through remote E-voting system were unblocked on Tuesday, 27th April 2021 at around 12.26 P.M. after conclusion of the NCLT convened Meeting in the presence of two witnesses viz. Ms. Shambhavi Wagle presently residing at Flat No B-1, Anandvan Society, Vrindavan Housing Complex, Kothrud, Pune 411038 and Mr. Prabhanjan Ghatpande, presently residing at Flat No A1-403, Sun Horizon, Baner Pune – 411045, who are not in the employment of the Company. Thereafter, the details containing, inter-alia, list of Equity Shareholders, who voted "for" and "against", were downloaded from the Evoting website of CDSL (www.evotingindia.com).

5) Voting at Meeting:

After declaration of commencement of E- voting during the conduct of the NCLT convened Meeting, the Shareholders who had not voted through the remote E-voting process were instructed to cast their vote on the E-voting platform provided by e-voting website of CDSL (www.evotingindia.com). This Facility was made available during the Meeting and for another period of 15 Minutes after the Meeting. After the conclusion of the NCLT convened Meeting the details containing inter-alia, list of Equity Shareholders, who voted "for" and "against", were downloaded from the E-voting Website of CDSL (www.evotingindia.com). The votes cast through remote E-voting and E-voting conducted during the meeting



were reconciled with the records maintained by the Company / Registrar and Transfer Agents of the Company and the authorizations lodged with the Company.

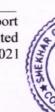
